Sl. No.	The school is directed to ensure that :
1	The total number of section of the school shall be restricted to 32 on the basis running sections and further increase of section shall be subject to specific approval of the Board on the basis of the request of the school as per Affiliation Bye Laws and subject to the availability of room size of greater than 500 sq ft.
2	The school has converted regular cubicles into CWSN toilets which are too small and narrow for a wheelchair/walker to navigate. A moveable/temporary seat has been placed on WC and there are no fixed support bars/rods inside, which is not acceptable as it is not as per norms. The separate toilets shown at the ground floor are also not CWSN friendly. The positioning of WC is wrong and would be difficult to access by CWSN in a wheelchair/walker. There are no support rods. There is no ramp to access these toilets, which have a raised entrance. The proposal of the Principal to use wooden wedges is unacceptable as they are moveable and hence dangerous for CWSN to

	navigate. The signage is temporary(paper pasted on door). The school shall construct separate toilets for CWSN, boys and girls, on every floor with proper permanent signage indicating the floor number, which are readily accessible through concrete ramps, as per norms of RPwD Act and guidelines issued by the Board within 3 months and submit compliance on SARAS portal.
3	The absence of an exhaust system, necessary for the safety of the composite lab has been noted by RC. The school shall provide for the same and shall upgrade the lab as per SoP of the Board within 3 months and submit compliance on SARAS.
4	The school shall conduct training of its teachers with CoE Chennai within 3 months and submit the compliance.

Compliance of the above mentioned points shall be submitted within 03 months on the SARAS Portal. Failure to comply within the prescribed time shall invite financial penalty @ Rs. 50,000/- every month until compliance is submitted and shall debar the school from filling the registration and LOC of students class IX to class XII, as the case may be.

The approval of the Board as mentioned above, is subject to the following conditions:-

- The school shall be responsible for its genuineness of the documents/ data/ information uploaded by the school. In case of any discrepancies, action will be initiated against the school as per Affiliation Bye -Laws-2018.
